### **Remote Deposit Capture Requirements**

To manage the increased risk created by the Remote Deposit Capture, per regulation, members using Remote Deposit Capture from our Mobile App are required to restrictively endorse the original checks prior to scanning and transmitting them for deposit to the credit union as shown below.

> For Mobile Deposit Only Account Number Credit Unions Name Member's Signature

If a check submitted by Remote Deposit Capture does not have this information, it will be

returned, as required by regulation.

### Effective May 1st - Debit Card Daily POS Purchase Limit In Place

Effective May 1, 2019, New Horizons Credit Union's Visa Debit Card's maximum Point-of-Sale (POS) purchases cannot exceed \$2,500.00/day without prior notice to the Credit Union. This daily purchase limit is due to increasing fraudulent transactions that get reported each year involving debit cards and is an attempt to further protect our members' accounts and minimize identity theft losses.
