### June Fraud Tips

Below are some tips to keep your identity safe.

- **Verify all financial communications:** NHCU will never text, email, or call asking for account or personal information. During Business hours, call (215) 316-3240 to verify the communication.

- **Check your credit report regularly:** Monitor your credit history for any unauthorized accounts or activity that could indicate identity theft.
- **Change all your passwords every 3 months:** Changing passwords periodically can prevent hackers from getting access to your accounts.
- **Be Cautious with Public Wi-Fi:** Avoid accessing sensitive information like bank accounts or making purchases when connected to unsecured public Wi-Fi networks, as they can be a hotspot for scammers.
