- Applicant must have a primary membership with New Horizons Credit Union, not a joint owner of an account, and the account must be in good standing.
- Applicant must be a graduating high school senior and will attend an accredited college, university, community college, or technical school and will be considered a full-time student.
- Applicant must request a sealed official high school transcript to accompany this application and other documents required.
- Completed application with supporting transcripts and any other documentation must be received by **April 1st, 2022** to qualify.
- Applicant and parent/guardian understands that if selected as a winner of the New Horizons Credit Union Scholarship, the Credit Union may publish the winner's name and likeness in any media, including social media, for commercial and promotional purposes, and without compensation.
