Important Change in Terms Notice

Regulation CC & the Expedited Funds Availability Act Schedule Changes

Change in Terms: Effective July 1, 2020, our Funds Availability Schedule will change as follows:

- If we place a hold on your deposit, the first\$225.00 of your deposit will be available on the first business day after the date of your deposit;
- Longer delays may apply if you deposit checks totaling**\$5,525.00** on any one (1) day; and
- For New Accounts, the first **\$5,525.00** of a day's total deposits of cashier's, certified, teller's, traveler's and federal, state and local government checks will be available on the next business day after the day of your deposit if the deposit meets certain conditions. The excess over **\$5,525.00** will be available on the ninth business day after the day of your deposit of these checks (other than a U.S. Treasury check) is not made in person to one of our employees, the first **\$5,525.00** will not be available until the second business day after the day of your deposit.

Always Be Aware of Potential Scams

Always remember, your Credit Union has safeguards in place to protect your personal information. However, there are things you can do to protect yourself.

Do not give out personal account information via email, text, or phone without first confirming the requestor's identity. Please know that we may contact you if fraud is suspected, but NHCU will never ask for your personal information such as online credentials, your card number, account number, or social security number via email, voice mail, or text messaging.

It's a good idea to sign up for our Free Online & Mobile Banking service so you can check your accounts frequently for any suspicious activity. If you suspect any fraud, please notify our Member Services Center immediately, or call the number located on the back of your card.

Independence Day Closing

We will be closed Saturday, July 4th in observance of Independence Day. ATMs and Online Banking will remain available during this time.

Be sure to <u>sign up for remote deposit capture</u>, which offers the convenience of depositing checks from wherever you are.
