## New Horizons Credit Union – National Credit Union Youth Month Drawing "Savings Carnival"

- **1. Eligibility:** No obligation necessary to participate and win. All participants must be parents or legal guardians of the New Wave Saver (minor) and be of legal age in their state of residency at time of contest participation.

Any questions regarding the number of Entries submitted shall be determined by New Horizons Credit Union in its sole discretion, and New Horizons Credit Union reserves the right to disqualify any entries by persons determined to be tampering with, violating, or abusing any aspect of the contest.

- **3. Contest Entry Requirements:** In the event the Credit Union, in its sole discretion, determines that any entry does not comply with these Official Rules or does not otherwise comply with regulatory guidelines, the Credit Union reserves the right to disqualify the entry.
- **4. Determining the Winner:** A Credit Union contest committee will draw three (3) random winners from all entries received, with first place being the first random name drawn, etc. Three (3) winners will be announced via New Horizons Credit Union Facebook by Friday, May 23, 2025, at 10 A.M. CT. The winners do not have to be present to win. The winners will be contacted via phone or email. The winners will be responsible for picking up the prize at a designated New Horizons CU office.
