

I Love My Credit Union Day \$100 Visa® Gift Card Giveaway – Official Drawing Rules

1. Eligibility: No purchase or obligation necessary to participate and win. All participants must be 19 years of age (Alabama resident) or older, or of legal adult age in their residing state at time of contest participation and must be members of New Horizons Credit Union. Employees of New Horizons Credit Union, their immediate families (spouses, parents, children, and siblings, & each of their respective spouses), & members of the household of such individuals are not eligible to enter the drawing.

Determining the Winner: A New Horizons Credit Union employee will select at random one (1) Grand Prize Winner from all entries received with the Drawing to be held Tuesday, August 1, 2023, at 11:00 a.m. CT. The winner does not have to be present to win. The winner will be contacted via private message on Facebook, or through the phone and email address provided from entry dropped off at a New Horizons Credit Union branch or emailed to marketing@newhcu.org. The winner will be responsible for picking up the prize at the New Horizons Credit Union Corporate office located at 622 Azalea Rd. Mobile, AL 36609, or at a designated New Horizons Credit Union branch.

5. Prize: One (1) \$100 Visa® Gift Card. Prize is non-transferable. Federal, state, and local taxes are the sole responsibility of the winner. Odds of winning depends on the number of entries – example: 100 entries mean odds of 1 in 100 of winning.
