Change in Branch Hours

Due to the COVID-19, limited staff, and safety concerns, New Horizons Credit Union will no longer offer Saturday hours of operation after August 15, 2020.

However, Friday branch drive-thru hours of operation will increase to 9 a.m. to 6 p.m. CT starting Friday, August 21, 2020.

New Horizons Credit Union does not make this decision lightly and realizes this may cause inconvenience to our members. Unfortunately, the recent increase in reported cases

concerning the pandemic has forced us, as well as many other businesses, to operate differently. We continue to encourage usage of our free 24/7 electronic services, branch night drop boxes for deposits and payments, and enrollment in our Visa Debit Card which offers surcharge-free transactions at over 55,000 Allpoint ATMs nationwide.
