#### \*NEW\* Principal Payment Option Available for Select Loan Products

Members with a New Horizons CU loan are now able to make a Principal Only Payment. Members must still make a full loan payment each month, but members can now make an extra

payment to go towards PRINCIPAL only. This will not advance a due date or change the amount of each monthly payment – however, it will allow you to pay off the loan quicker by reducing the amount borrowed.

Note: This does not apply to Home Equity Line of Credits and Credit Cards.

between the ages of birth-18, a youth account called <u>New Wave Savers</u>. This youth account offers a first step towards teaching financial responsibility and offers other opportunities.





## Visa® Credit Card Information Behind Online Banking

NHCU Visa<sup>®</sup> credit cardholders are now able to retrieve their credit card information, make payments, check rewards, and view all usual credit card information with the convenience of Online



Note: Some mobile devices may not be compatible to retrieve Credit Card information behind Online Banking. The payment/reward button on the <u>Visa®</u> <u>Credit Card page</u> is still available if needed for Mobile device access.

Members using our Credit Card to make purchases may qualify to earn CUReward points. These CUReward points can be used to purchase merchandise and for travel. Effective June 30, 2022, points exchanged for travel purposes will receive a Travel Gift Card to offer better direct control of travel plans and eliminate the hold time from a Travel Agency. #### May Fraud Prevention Tip: Avoid Misleading Discounts Online

Recently, there have been a number of reports made about misleading online discounts that are designed to steal unsuspecting victims' credit card information.

#### How the Scam Works

You see an ad for a product on social media or in an online search. A company is offering new customers a significant discount on a product. In some cases, the product seems to be endorsed by a celebrity. For example, recent Scam Tracker reports mention TV show Shark Tank, actor Kevin Costner, actress Mayim Bialik, and journalist Katie Couric.

Sounds great, right? Unfortunately, if you order the discounted products, the scammers now have your credit card number. Victims report being charged for extra or ongoing monthly subscriptions that they never agreed to. Other victims report being charged random amounts for products they never received.

Once scammers have your credit card information, canceling is not easy. Consumers report that scammers used numerous excuses to avoid issuing refunds. They claimed everything from trouble with the computer system to it being outside the cancellation window. Many victims report that the charges continued even after they canceled their subscription.

#### How to spot these scams

- Research the company online. See what other people are saying about the company's free trials. Complaints from other customers can tip you off to "catches" that might come with the trial. Check the business's BBB Rating and see if there are any alerts.
- Be skeptical of celebrity endorsements. Resist being swayed by the use of a well-known name. Scammers often fake celebrity endorsements.
- Report losses to credit card companies. If you pay with a credit card, you can dispute fraudulent charges. Keep an eye on your monthly statements and notify your credit card company of any suspicious charges.
