### Individual Retirement Accounts (IRAs) May Help Defer Some Taxes\*

New Horizons Credit Union offers several IRA investment options to choose from and each is federally insured up to \$250,000 per member (separate from your other New Horizons Credit Union accounts) by the National Credit Union Administration.
