- Applicant must request a **sealed official high school transcript** to accompany this application.
- Completed application with supporting transcripts and any other documentation must be received by **April 1, 2024**, to qualify.
- Applicant and parent/guardian understands that if selected as a winner of the New Horizons Credit Union Scholarship, the Credit Union may publish the winner's name and likeness in any media, including social media, for commercial and promotional purposes, and without compensation.
